

# Ridge and Valley Charter School Behavior Rubric

*This behavior rubric applies to behaviors that take place on school property, school-sponsored events or on a school bus, and includes any electronic communications that take place off-site and cause substantial disruption/interference to the school day.*



<ul style="list-style-type: none"> <li>• Poor sportsmanship in sports, games, cooperative learning; leaving someone out.</li> <li>• Disruptive behavior such as running on deck or away from the group, or exhibiting excessive noise.</li> <li>• Use of inappropriate language or gestures not targeted at an individual.</li> <li>• Disrespect towards staff or others by words or actions, i.e., rolling eyes, reactive comments, etc.</li> <li>• Possession and/or use of unauthorized electronic devices during the school day.</li> </ul>	<ul style="list-style-type: none"> <li>• Mistreating other's property or threatening to break something.</li> <li>• Rough physical contact with other students and/or Guides.</li> <li>• Throwing or swinging objects.</li> <li>• Violation of RVCS Field Trip/Expedition Agreements.</li> <li>• Talking negatively behind someone's back, starting or spreading rumors, including electronic communication on or off school premises that causes substantial disruption to the school day.</li> <li>• Negative or rude gestures towards another student or a Guide.</li> <li>• Use of explicit language or swearing.</li> </ul>	<ul style="list-style-type: none"> <li>• Stealing or destroying other's property.</li> <li>• Threatening to hurt someone or using slander, including written and electronic communication on or off school premises.</li> <li>• Physical assault of severe hitting/ shoving/slapping/ punching/kicking/ spitting/ touching private parts.</li> <li>• Possession/use of weapons.</li> <li>• Credible threat to school or others.</li> <li>• Harassment, intimidation and bullying based on body shape/size/attire/ disability/race/gender/ gender identity/ religion. (possible HIB*)</li> </ul>
<ul style="list-style-type: none"> <li>• Addressed by staff or class group.</li> <li>• Possible parent notification and removal from class activities.</li> <li>• Can be referred to Leadership Team, if not resolved.</li> <li>• Can be seen as <b>Orange</b> behavior if not resolved.</li> </ul>	<ul style="list-style-type: none"> <li>• Parent notification.</li> <li>• Possible Quiet Lunch and/or removal from the class group.</li> <li>• Possible suspension from trips and/or school activities. (<i>grades 3-8</i>)</li> <li>• Possible Behavior Contract.</li> <li>• Can be seen as <b>Red</b> behavior if not resolved.</li> </ul>	<ul style="list-style-type: none"> <li>• Removal from the class group.</li> <li>• Incident documented &amp; sent to Leadership Team.</li> <li>• Parents contacted &amp; possibly the authorities.</li> <li>• Probable suspension from trips and/or school. (<i>K-8 for weapons and 3-8 for all other incidents</i>)</li> <li>• Interview upon re-entry.</li> </ul>
